## Make sure to bring the following documents with you to the tax site.


- ≥ All W-2s and 1099s (if any)
- Social Security Cards or Individual Taxpayer Identification Numbers (ITIN) for all family members
- ▶ Valid photo ID
- Copy of last year's tax return, if available
- Bank Account Number and Routing Number to direct deposit your refund
- ▶ Property tax bill
- Amount spent on college expenses
